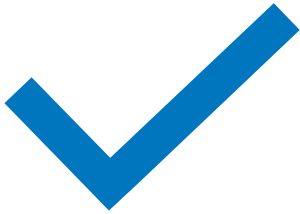
Battelle

STEMxcelerator Overview

- Funded by Battelle
- Two \$25,000 grants for K–12 STEM education solutions
- Hosted at STEM Innovation Forum, Columbus, OH
- Four finalists will their ideas live on Nov 18, 2025 at the Forum



Program Objectives

Battelle seeks to fund programs designed to accelerate innovative practices that:

- Strengthen STEM workforce readiness through career exploration, mentorship, work-based learning, or career pathway development.
- Expand access to high-quality STEM experiences for K–12 students.
- Introduce or scale innovative learning models that foster STEM identity, collaboration, creativity, and problem-solving.

Timeline

- Oct 12 – Proposals Due
- Nov 7 – Finalists Notified
- Nov 17 – Pitch Rehearsal
- Nov 18 – Live Pitch & Winner Announcement
- Post-award, grantees will complete a Student Impact Report
 - Reporting period: October 1, 2025 – September 1, 2026
 - Report opens: July 31, 2026
 - Report due: August 14, 2026

Proposal Requirements

- U.S.-based 501(c)(3) and 170(c) organizations
- One proposal per organization
- Must include a partner from: higher education institution, industry, or community organization
- Letter of commitment required from named partner(s)
- 20% in-kind match required by applying organization
- At least one representative from the applying organization must be registered for the STEM Forum at the time of submission

Proposal Narrative Sections

- A. Program Summary (500 characters)
- B. Program Description (4,000 characters)
- C. Innovation & Access (2,500 characters)
- D. Timeline & Location (4,000 characters)
- E. Measurable Outcomes (2,500 characters)
- F. Partnership Strength (2,500 characters)
- G. Student Impact (4,000 characters)
- H. Funding Request ($\leq \$25,000$; indirect $\leq 10\%$)
- I. Budget Narrative (2,500 characters)

Required Attachments

- Budget Template: <http://tiny.cc/stemxbudget>
- IRS Determination Letter (501(c)(3) organizations)
 - 170(c) organizations can submit IRS Governmental Information Letter or a W-9 and NCES District ID
- Letters of Commitment from partnering organization(s) named in the proposal
- *Optional: Up to 3 pages of supporting materials*

Evaluation Criteria

- **Innovation and access** – unique and engaging approach aligned to program objectives (20%)
- Feasibility and timeline – detailed plan from development to implementation (10%)
- Measurable outcomes – at least two quantifiable goals and evaluation methods to measure those goals (10%)
- **Strength of partnerships** – strong collaboration, clearly defined roles (20%)
- **Student impact** – defined participants, anticipated number of students served, recruitment strategy (20%)
- Budget – \$25,000 or less, indirect not to exceed 10%, detailed in-kind match (10%)
